Preamble

Children's Right to Free and Compulsory Education Act, 2009 has been made applicable to all schools in the State. In this regard the policy decision has been taken to adopt the procedure of Letter of Intent and Letter of Approval while granting the recognition to all new private Primary, Secondary and Higher Secondary Schools in the State. Accordingly, to grant the recognition and NOC on permanent non-grant basis to the

English Medium Schools of CBSE, ICSE etc. Boards, detail procedure has been laid dawn as per Government Resolution dated 20 June 2012.

2. Government has passed the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 in the year 2013, which has been implemented from the academic year 2013-14. In view of this Act-the applications were called in February, 2013. The 2417 applications have been considered eligible out of 7108 applications received after the scrutiny on 15 May, 2013. The proposals found eligible were under consideration of the government as how to take action. After considering the all facts the government has taken the following decision.

Government Resolution-

(1) According to Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012, following 2417 proposals are declared fit out of 7108 proposals received for the academic year 2013-14.

- (2) The permission is granted to 440 eligible schools under upgradation to start the classes from the academic year 2013-14.
- (3) Proposals for New Schools The permission is granted to 1977 new schools which have been found eligible as above.
- (4) No independent approval is given to the Pre-Primary Schools, that have been granted adjoining to the primary schools. Accordingly, the permission to the schools which are to be started under this order will be granted from class I.
- (5) There will be no change in medium of instruction, place of school etc. in future which have been prescribed for permission by the institutions. If school has been started in a place other than the place of school approved by the government, the approval so granted will automatically be treated as cancelled. The permission so granted for



establishment or upgradation of the school under the provisions of this Act will be for the academic year for which the permission is granted, and if the management fails to start the school within eighteen months from the date of permission, the said permission will automatically be treated as cancelled.

- (6) It will be obligatory on the part of new/upgraded schools which have been given approval in attached pro-forma statement to follow the orders and procedures issued by the government time to times and provisions of the Children's Right to Free and Compulsory Education Act,2009 and Maharashtra Self financed Schools (Establishment and Regulation) Act, 2012.
- (7) The concerned applicants should be intimated personally by the member secretary of the scrutiny committee of the concerned district keeping the receipt of the same in the record of the government regarding the district wise details of proposals shown in the attached pro-forma statement which have been found ineligible for establishment of new school or upgrading the existing schools.
- (8) It will be necessary to take the note/No. as schools approved on self-financed basis while filling the information in district wise DISE Data for the new/upgraded schools permitted in attached pro-forma statement. In this regard, the further action would be taken by the State Project Director, Maharashtra Primary Education Council, Mumbai. Accordingly, it will be necessary to depict the "Approved new/upgraded School on self-financed basis" on the notice board outside of the school for the information of all concerned.
